

Standardised Pricing and Disclosure of Interest

All funeral directors are legally required to publish this Price List for a standardised set of products and services. This is to help you think through your options and make choices and to let you compare prices between different funeral directors as prices can vary.

Attended funeral (funeral director's charges only) £3095.00

This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation.

Unattended funeral

This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial or cremation itself.
